EXECUTIVE SUMMARY

The staff of the Office of the Director of Public Prosecutions exemplified high

morale and remained dedicated to two of the most critical objectives of the Department,

to continue to present criminal cases before the courts in a timely and efficient manner

and to continue to provide the citizens of Jamaica with a professional prosecution

service that is fair to both victim and accused.

This was achieved during the period under review March 26, 2008 to

March 31, 2009. Not withstanding the challenges of the spiraling crime rate with it

attendant impact on an already burdened justice system.

The major objectives pursued by the Office of the Director of Public Prosecutions

during the period March 26, 2008 to April 3, 2009 were as follows:-

To implement systems conducive to managerial best practices to facilitate

operational efficiencies

To fill existing vacancies so that prosecutorial capability of the Department

could be increased

• To continue to present criminal cases before the courts in a timely and

efficient manner

To continue to provide the citizens of Jamaica with a professional prosecution

With these objectives the Department continued its efforts to:-

Provide more opportunities to expose prosecutors to the necessary skills and

techniques to enhance their prosecutorial capability

Staffing

Subsequent to written administrative justification by the department for an

increase in the prosecutorial staff complement, approval was received from the Cabinet

Office and the Ministry of Finance to increase the staff complement as follows:-

3 Paralegal Officers

1 Records Clerk

Training

Improved Facilities

A Beautification Committee was appointed to improve the general appearance of

the Office.

The Office purchased an Ice-maker and so cool drinking water was more readily

available daily during the period under review. This contributed to improved staff

morale.

Court Activities

Once again the activities of the various courts fell below the Department's

Department were the main contributing reason.

Insufficient jurors to try the number of cases listed was one obvious factor and

the fear of Crown witnesses attending Court to testify at a trial was another.

The implementation of the Criminal Case Management System is still to become

Nolle Prosequi

Under Section 94 (3) the Director of Public Prosecutions has the power to

terminate prosecutions in all the Courts in Jamaica. During the period under review the

Director entered **304** Nolle Prosequis.

Extradition Requests

18 extradition requests were received. **10** persons were extradited.

Mutual Legal Assistance Requests (Requests from Foreign States to Jamaica)

The Department received **25** requests. **11** requests were completed and **12** are

pending and 2 are not being pursued.

Jamaica Mutual Legal Assistance (JAMLA) Requests (Request by Jamaica to

Foreign States)

16 requests were made, 4 requests were completed and 12 are pending.

Circuit Court Cases Listed for Trial

There was a significant increase in the number of cases listed for trial in the

Rural Parish Circuits and the Home Circuit Court. There were 1130 cases in the Rural

Parish Circuits 440 cases were disposed of, 1052 cases in the Home Circuit Court and

187 cases were disposed of. The rate of disposal of the cases was as very low. A

number of factors contributed to the very low rate of disposal of the cases listed for trial.

Among them were insufficient jurors and requests for adjournments by defence counsel.

Rural Gun Court

552 cases were listed for trial 231 cases disposed of.

Regional Gun Court

286 cases were listed for trial 221 cases disposed of.

Files for Rulings

520 files were received as it relates to complaints by the public against the

police. **383** files were ruled on.

<u> Justice Protection Unit – Witness Protection Unit</u>

The Justice protection Unit manages the Witness Protection Unit. The

Department continued to collaborate with law enforcement officers in facilitating the

efficient collection, processing and presentation of evidence for the courts. The judicial

process has benefited from the operation of the Witness Protection Programme where

the Director of Public Prosecution's Office acts as the liaison between these witnesses

and the Justice Protection Unit otherwise called the Witness Protection Programme.

A Committee was set up recently to examine the programme and recommend

improvements to make it more structured and with a legal frame work.

Human Trafficking

The Human Rights, Intellectual Property and Financial Services Matters Unit

continues to make much headway in the Human Rights area of Trafficking in persons.

Presently, the Director of Public Prosecutions Office is represented on the National Task

Force in Trafficking in Persons which allows for the Department to directly influence the

process. Two cases were listed for prosecution. One case was satisfactorily completed

after the accused persons pleaded guilty of the charge. The other case was traversed to

the next circuit.

SUMMATION

Facts

With the exception of Files submitted for Rulings there was an increase in

criminal matters listed for trial. The situation as it relates to Files for Rulings showed a

decline simply because special arrangements were put in place to clear the backlog of

Files for Rulings.

It is now imperative that creative measures to be introduced to address the

increasing number of criminal matters listed for trial.

ACTION PLAN

Criminal Case Management System

The implementation of the Criminal Case Management System must now be

given priority treatment. The stakeholders i.e. The Prosecution and the Defence must

now examine the matters listed for trial and be prepared to discontinue the proceedings

for matters which cannot succeed at the prosecution level or work assiduously to get the

accused to enter a guilty plea.

Some Reasons for Low Disposal Rate

A quick review shows that with the exception of the Regional Gun Court the

disposal rate for the cases listed for trial in the Rural Parish Circuit Courts and the Home

Circuit was well below 50%. Some of the reasons for the low disposal rate are as

follows:-

• The problem of reluctant witnesses who were fearful of coming forward to give

their evidence

• The lack of sufficient persons to serve as jurors

The unavailability of some Doctors to give evidence on behalf of the Prosecution.

Sometimes the Doctors provide service to hospitals and could not fit into the

court's schedules

There were matters which had a number of witnesses and multi-accused.

These cases proved time consuming and kept the Courts occupied. This resulted

in the displacement of subsequent matters as they could not commence

• The extraordinary long time it takes the Prosecution to obtain DNA results from

the Forensic Laboratory for some of the cases listed for trial.

• The Defence applications for adjournments

Extension of Rural Circuits & Increase in the Prosecutorial Capability of the Office

of the Director of Public Prosecutions

There are instances where cases listed for trial for a three (3) week period was in

excess of thirty (30) cases. The duration of some of the trials was four (4) days.

Sometimes a maximum of four (4) cases were disposed of. On those occasions as

many as twenty six (26) cases were traversed.

The increasing number of criminAl matters listed for trial in some of the Rural

Circuits necessitate that consideration be given to the extension of the periods now

being designated.

This, however, will give rise to the Justice system's capability to man these

extended periods both in terms of Court room facilities and legal and administrative to

man the courts. For the Office of the Director of Public Prosecutions an increase in the

number of Prosecutors on the establishment would be a necessity if there is to be an

extension of the duration of the sittings of the Rural Parish Circuits.

THE ESTABLISHMENT

The Office of the Director of Public Prosecutions is a public office.

It was

created under Section 94 (1) of the Constitution of Jamaica.

The Director of Public Prosecutions heads the Office of the Director of Public

Prosecutions. The Governor General appoints the Director.

"A person shall not be qualified to hold or act in the Office of

Director of Public Prosecutions unless he/she is qualified for

appointment as a Judge of the Supreme Court".

The Office of the Director of Public Prosecutions is responsible for all criminal

prosecutions throughout the island of Jamaica. The Director under Section 94 (3) has

the power, in any case, in which he considers it desirable so to do:-

(a) to institute and undertake criminal proceedings against any person before any

court other than a court-martial in respect of any offence against the law of

Jamaica;

(b) to take over and continue any such criminal proceedings that may have been

instituted by any other person or authority; and

(c) to discontinue at any stage before judgment is delivered any such criminal

proceedings instituted or undertaken by himself or any other person or authority.

The powers referred to under Section 94 (3) rests the instituting of a prosecution

in the discretion of the Director of Public Prosecutions.

THE FUNCTIONS

The Director of Public Prosecutions, under Section 94 (3) of the constitution has

the power initiate, take over and terminate prosecutions in all the Courts in Jamaica.

Crown Counsel represent the Director in criminal cases in the Supreme Court, the

Circuit Courts, and the Gun Court. They also appear in complex or technical matters in

the Resident Magistrates' Courts and appear weekly in the two divisions of the Court of

Appeal to deal with criminal matter appeals.

The Director of Public Prosecutions is responsible for:

(a) Instituting prosecutions. This entails requesting an investigation, the receipt of

Police statements and the decision to prosecute. The next stage is the

presentation of the case, which involves the preparation of the case, and the

presentation of the evidence in court.

(b) Other matters such as bail applications, change of venue, criminal appeals to the

Court of Appeal of the Judicial Committee of the Privy Council.

(c) Taking over and continuing or discontinuing a particular case in any of the Courts

in Jamaica

(d) Supervising all Clerks of the Courts in prosecutions in all parishes in Jamaica.

In keeping with the functions outlined above the Department committed itself to

achieving the following objectives for the period APRIL 1, 2008 to March 31, 2009.

Some of the objectives had their own challenges in addition to the limited number of

reluctance of persons to serve as juror or give witness on behalf of the Crown.

To continue to reduce the caseload for some of the Crown Counsel thereby

allowing them more time to direct their attention to reducing the number of

outstanding opinions/rulings in their possession

• To continue to provide opportunities and facilities to expose prosecutors to the

necessary skills and techniques to enhance their prosecutorial capability

To recruit Crown counsel to fill existing vacancies to ensure the presentation of

cases in a timely manner

• To train members of staff in computer applications relating to the implementation

of the Criminal Case Management System.

To work with all stakeholders to implement the Criminal Case Management

System

<u>ADMINISTRATION</u>

Budget Allocation

The approved budget for the Office of the Director of Public Prosecutions for the

financial year April 1st 2008 to March 31st 2009 was \$180,768,000.00. This was an

increase of \$32,767,000.00 over the previous year. The actual expenditure for the

period under review was \$180,943,472.44. The Department was unable to attract

experienced persons to fill existing senior vacancies on the establishment because the

remuneration was not competitive. Notwithstanding this fact as was the case in the

previous year, the largest portion of the budget was spent on employees' compensation

and related Travel and Subsistence expenses.

RE-ENGINEERING OF THE DEPARTMENT

Establishment of a Management Committee

The newly appointed Director of Public Prosecutions, Miss Paula V. Llewellyn,

Q.C. wishing to have greater participation in the operation of the Department established

a Management Committee and a Director's Council. The Management Committee met

every six (6) weeks and the Director's Council met monthly. A number of management

systems were established to enhance accountability and managerial best practices.

STAFF RELATED MATTERS

<u>Staffing</u>

It became apparent that the existing staff complement could not efficiently handle the backlog of files for rulings and efficiently prosecute the number of cases waiting for trial. Written justification was submitted by the Director of Public Prosecutions for an increase in the Establishment. The Cabinet Office and the Ministry of Finance approved eleven (11) additional posts. The addition included one (1) Deputy Director of Public Prosecutions two (2) Assistant Director of Public Prosecutions four (4) Crown Counsel three (3) Paralegal Officer and one (1) Records Clerk.

Engagement of Former Prosecutors

There were a number of complex criminal matters to be prosecuted, however, the majority of existing prosecutorial staff were not experienced enough to handle these matters. Permission was sought to engage the services of former Prosecutors to be engaged at concessionary rates to assist with the prosecution of some of the complex cases. The services of eight (8) former Prosecutors were engaged during the period April 2008 to March 2009

STAFF CHANGES

<u>Departures</u>

During the period under review the Department lost one (1) of its more experienced prosecutors and one of its Administrative staff proceeded on early retirement.

Employment

Seven (7) new Crown Counsel joined the Department during the period under review. As is the norm these persons are usually not experienced enough to take on major assignments on their own and so could not contribute to reducing the Department's workload. They were assigned to appear with senior experienced Crown Counsel to be mentored.

IMPROVED FACILITIES

Internet Access

The Office has allocated a computer to each Crown Counsel and the Secretarial

support staff. Internet access is now available so Crown Counsel have access to the

latest authorities in order to properly prepare their cases. Problems with the Lime facility

impacted on the Server and persons had problems connecting to the Internet at times.

This problem severely inconvenienced the Extradition and the Mutual Legal Assistance

Units who needed to communicate with overseas entities because of the nature of their

work.

SUMMARY OF COURT ACTIVITIES FOR THE PERIOD

MARCH 26, 2008 - APRIL 3, 2009

Nolle Prosequi Granted

The provisions of Section 94(3)(b) and (c) give the Director of Public

Prosecutions the power to discontinue prosecution of any case being undertaken in the

Resident Magistrates' Courts or the Supreme Court. During the period under review 304

Nolle Prosequis were entered broken down as follows:-

228 Voluntary Bill of Indictment were entered. (This means that the matters

are removed from the Resident Magistrate's Court and brought to the Home Circuit

Court for trial without any preliminary enquiry)

24 Unconditional Nolle Prosequis. (Those matters come to an absolute end)

30 Nolle Prosequis because of Witness unavailability. (In the event that the

Witnesses are found or turn up at a later date those matters can be re-opened)

18 Nolle Prosequis relating to new RM. (In those cases the matters had

commenced before a particular Resident Magistrate but for one reason or another, the

Resident Magistrate was not able to complete the matter. Nolle Prosequis are entered

so that those matters can recommence before a new Resident Magistrate).

4 Nolle Proseguis were entered in the Gun Court.

Extradition Requests

18 extradition requests were received and there were **10** extraditions.

5 requests are still being processed. **13** requests were received from the United States

of America and 3 from the United Kingdom. (See Table 1 for more details)

Mutual Legal Assistance Treaties Requests

25 requests were received during the period under review. 11 requests have

been completed 12 are still being processed and 2 are not being pursued. The United

Kingdom made **14** of the requests. (See Table 2 for details).

completed and 12 are pending. (See Table 3)

Circuit Court Cases

The Department continued to collaborate with the law enforcement officers

providing guidance where necessary to ensure that the presentation of evidence for the

courts is at the highest level thereby contributing to the delivery of justice in an efficient

and timely manner.

Rural Parish Circuits

1130 cases were listed for trial, 440 or38.93% of the cases were disposed of and

690 or **61.06%** of the cases were traversed to the next term. Murder cases accounted

for **382** of the cases listed and sexual offences for **508**. The parishes of St. Thomas

(154), St. Catherine (134), and St. James (120) accounted for the highest number of the

cases listed for trial. (See Table 4, 4a, 5 & 5a for more details).

Home Circuit Court

1052 cases were listed for trial for the term. 187 or 17.78% cases were disposed

of and 865 or 82.22% of the cases were traversed to the next term. Murder and Capital

murder together accounted for 534 - the highest number of cases followed by 232 sexual

offences cases. (See Table 6 & 6a for details).

Gun Court Cases

Rural Gun Court

(Clarendon, St. Mary, St. Elizabeth, Manchester, Portland, St. Thomas and St, Ann)

552 cases were listed for the period under review. New cases accounted for

231. 210 cases or 47.85% of the cases listed were disposed of. 342 cases were

traversed to the next term. (See Table 7).

Regional Gun Court

(St. James, Trelawny, Westmoreland and Hanover)

228 new cases were listed for the period under review. The total number of

cases listed for trial was 286. 221 cases or 77.27% of the cases listed were disposed

of. 65 cases were traversed to the next term. St. James with 143 cases accounted for

the most of the cases or 50.00% of the cases listed for trial. The category "Other"

includes cases that were transferred to the Resident Magistrates' Courts, cases for

which Nolle Prosequis were entered by the Director of Public Prosecutions or instances

where the persons are deceased. (See Table 8).

Files for Rulings

520 files were received from the various bodies for rulings in relation to police

excesses in the performance of their duties. The majority of the complaints 234 were

received from the Bureau of Special Investigations. Police Public Complaints Authority

with 130 was next in line. There was a noticeable decrease in the number of files

submitted for rulings during the period under review. 383 rulings were made.








